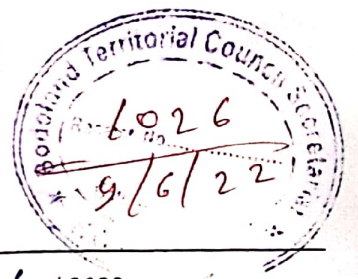

1. The work order will be served as per the decision of the Circle Level Tender Assessment Committee.

Technical Bid

1. PAN Card (self attested).
2. GST Registration Certificate (self attested).
3. IT Returns of last 3(three) years (self attested).
4. Work order of completed works in last 5 years mentioning the total value of work order related to civil construction. (2019-20, 2018-19, 2017-18, 2016-17, 2015-16).
5. Total Annual turnover along with Balance Sheet certified by Chartered Accountant for last 3 years. (2019-20, 2018-19, 2017-18).
6. Balance sheet verification certificate from C.H.D., Forests, B.T.C. should be submitted.

Financial Bid

1. The limit for financial bid value shall be between Minus (-) 10% to (+) 10 Percent of the internal estimate. Any bids beyond above said limits shall be out rightly rejected at the time of opening of the financial bid.
2. Incase Multiple bidders bidding at the same rate, the bidder having higher score based on the following shall be recommended for award of contract.
3. 40% of the value of all civil works (in Rupees) completed in last 5 years. In case of equal score of two bidders as described in Point No. (2) above the bidder having higher average Annual turnover in last 3 years will get preference.
